#### B1 Review of Group's performance

#### Overall review for the financial quarter ended 31 August 2023

For the financial quarter ended 31 August 2023, the Group posted higher revenue of RM7.8 million compared to RM7.3 million for the corresponding period last year. Consequently, the Group reported higher profit before taxation ("PBT") of RM0.3 million for the current financial period compared to RM0.2 million for the corresponding period last year.

#### Review of business segments for the financial quarter ended 31 August 2023

During the financial quarter ended 31 August 2023, the Logistics segment posted higher revenue of RM7.8 million compared to RM7.3 million for the corresponding period last year due to higher sales in tank farm business. Consequently, this segment reported a higher segmental profit of RM1.0 million compared to RM0.8 million in the corresponding period last year.

The results of others segment are mainly attributed to corporate expenses incurred by the investment holding company. This segment reported higher segmental loss of RM0.6 million compared to RM0.5 million in the corresponding period last year due to higher corporate expenses.

## B2 Material change in the results for the current financial quarter as compared with immediate preceding financial quarter

Revenue for the current financial quarter increased to RM7.8 million from RM7.7 million in the immediate preceding quarter. The Group reported PBT of RM0.3 million for both the current and immediate preceding financial quarter.

#### B3 Current year prospects

The domestic economy grew at a pace of 5.6% in January to March of 2023 after growing at 7.1 % in October to December of 2022. The services sector continued to show rapid growth of 7.3% in January to March of 2023 following growth of 9.1% in October to December of 2022. The economic expansion was supported by sustained domestic demand with private expenditure and improvement in labour market conditions.

The pace of expansion is expected to moderate during 2023 calendar year due to the impact of high base year effects as well as the economic slowdown in key markets. Inflationary pressure remains high, and many customers are still cautionary in their outlook. The Board will continue to exercise caution in managing the business under these conditions. Management will continue to explore ways to build new capabilities and capacities for long term growth.
