NOTES TO THE INTERIM FINANCIAL STATEMENTS - SECOND QUARTER ENDED 31 DECEMBER 2021

A1. Basis of preparation

The condensed consolidated interim financial statements are unaudited and have been prepared in accordance with the requirements of Paragraph 9.22 of the Main Market Listing Requirements ("MMLR") of Bursa Malaysia Securities Berhad ("Bursa Securities") and the Malaysian Financial Reporting Standards ("MFRS") 134: Interim Financial Reporting. This unaudited interim financial report should be read in conjuction with the Group's most recent audited financial statements for the financial year ended 30 June 2021.

A2. Significant Accounting Policies

The accounting policies and method of computation adopted by the Group in this interim financial report are consistent with those adopted in the annual financial statements for the financial year ended 30 June 2021 except for the following new/revised MFRSs and amendments to MFRSs:

Group's Financial Performance

The Group recorded a revenue of RM96.9 million for the financial quarter ended 31 December 2021 mainly from the piling and foundation services business segment. Revenue contribution from piling and foundation works from property development projects contributed RM88.9 million or 91.7% to the Group's revenue, (2QFY21 - RM74.7 million or 78.7%) and the remaining revenue derived from piling and foundation works from infrastructure and other segments amounting to RM8.0 million or 8.3% (2QFY21 - RM20.2 million or 21.3%).

The Group recorded gross profit of RM0.6 million and loss before tax of RM4.4 million for the current financial quarter ended 31 December 2021. The low gross profit margin of 0.6% (2QFY21 - 9.9%) was mainly due to losses of some completed projects, and the margin adjustments due to rising material prices both locally and overseas.

Other Income

Included in Other Income for the current financial quarter is rental income of equipment and disposal of property, plant and equipment amounting to RM0.8 million as compared to RM0.9 million in the preceding year.

Project Updates and Order Book

As at 31 December 2021, there are 25 on-going projects at various stages of completion. Order book stood at approximately RM0.69 billion as at 31 December 2021. Concentration of credit risk with respect of trade receivables is limited except for six (6) customers which accounted for 72.2% (including retention sum) of trade receivables as at 31 December 2021.

In the current second financial quarter ended 31 December 2021, the Group recorded a higher revenue of RM10.9 million to RM96.9 million from RM86.0 million in the preceeding quarter ended 30 September 2021. The piling and foundation works from property development projects and infrastructure projects during the current quarter ended 31 December 2021, amounted to RM88.9 million and RM8.0 million respectively, as compared to RM77.0 million and RM9.0 million respectively, in the preceeding quarter ended 30 September 2021. The higher revenue was mainly attributed to the normalisation of activities after the lockdowns in the preceeding quarter.

The loss before tax for the current quarter ended 31 December 2021 as compared to the preceding quarter ended 30 September 2021 was mainly due to the losses on completed jobs, margin adjustments due the rise in material prices and the adjustment in staff costs in December 2021.
